**Vehicle Private Property Impound Contract**

The parties do agree as follows:

1. **EASY TOWING LLC** will provide impound signs, and appropriate authorization form.

Owner/Agent authorizes EASY TOWING LLC to remove any and all vehicles at owners expense upon written authorization from the property described above, 24 hours a day. A FEE MAY APPLY FOR HULK VEHICLES.

2. **OWNER/AGENT** is not required to remove any vehicles from the above-described property.

3. **OWNER/AGENT** agrees to indemnify and hold EASY TOWING LLC harmless from any claims, causes of action, judgements and costs relating to the removal (impound) of any vehicle from the above-described property that arise from negligent acts or omissions of the agent or its employees. EASY TOWING LLC agrees to indemnify and hold harmless OWNER/AGENT from all claims for damage done to automobiles while being impounded or in storage at EASY TOWING LLC's storage lots.

4. **EASY TOWING LLC** agrees to maintain in effect an insurance policy with policy limits of not less than One Million Dollars to insure against risk arising out of the omissions or negligence of EASY TOWING LLC.

5. A person or agency authorizing an impound, if the impound is found in violation of RCW 46.55, may be held liable for costs incurred by the owner. Impound Rates: Class A: \$306.88 for the first hour. \$54.75 per 15-minute increments for the second hour or \$306.88 per hour.

This agreement shall continue in effect for one year from this date and shall be automatically renewed at the end of each one-year period, unless terminated in writing, by either of the parties thirty (30) days prior to the end of the contract term. If the property is sold or leased this agreement may be terminated.
